Police and district attorneys can help protect you against harassment and intimidation. Compensation applications and information on crime victim compensation may be found in every police station. You may also wish to contact a crime victims' rights program from the list provided below. Advocates are available to assist you in completing applications for reimbursement for losses or expenses related to this crime and to provide you with support services.
